Could this be a brother or nephew of Elizabeth nee Hesketh. I note there are many place names that contain the name Hesketh, in this area.

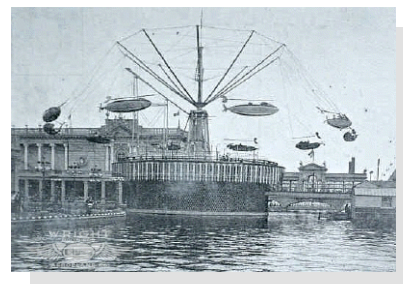

John Wright, Marshside Road, Southport, who was ex-chairman of the Southport Boating Company and member of the old Southport Lifeboat crew, died at his home, aged 75, today. He had also been pleasure steamer captain and manager of Sir Hiram Maxim's captive flying boats on Southport Pleasureland.

Sir Hiram Maxim, in 1878, lost a priority patent battle with Thomas Edison over the invention of the electric light. He next invented the machine gun, found the US Department of War unreceptive, and moved to England in 1881 where the Royal Army was more convivial. In England he devoted much of his life to research in aviation but made little substantial contribution. In his first public address on aeronautics, Wilbur Wright credited Maxim for making the first powered flight, although it was uncontrolled and could not be sustained. Maxim was convinced that propulsion was the central problem in aviation and built a lightweight steam engine that developed 180-horsepower. He mounted two of these on a huge multi-wing airplane and tested it on a track. The track was designed to hold the biplane down, letting it rise only a few inches. But during one test in 1894, the track failed to restrain the biplane and it took off with three people aboard, careened through the air for several hundred feet, and then crashed and was demolished. Thankfully none aboard were seriously injured. This was, as Wilbur pointed out, perhaps the first time an airplane took off from level ground under its own power. However, owing the lack of effective controls and a skilled pilot to man them, it could hardly be considered a flight. Nonetheless, he had many other successful inventions, among them the mousetrap and the bronchial inhaler. In 1901 Queen Victoria knighted him for his contributions to science and technology.

In 1904, he designed an amusement ride to help fund his research. Based on one of his aeronautical test rigs, he called it the Captive Flying Machine. Today it is better known as the Circle Swing and it's a staple at every carnival and amusement park. Maxim built a huge (but unsuccessful) biplane in 1910 and in 1911 he partnered with the pilots Claude Grahame-White and Louis Bleriot to develop an airplane capable of lifting a 500-pound (227 kilogram) payload that could be used as a bomber. Ill health prevented him from completing this project and he died in 1916.

TRAGEDY AT WILPSHIRE

MAN OF INDEPENDENT MEANS FOUND DEAD

A shocking tragedy was discovered at Wilpshire, near Blackburn, last night, when Mr Walter Halstead, a man of independent means, living at Prospect Villas, Wilpshire, was discovered dead, with a revolver in his right hand and a bullet wound in the temple.

He had been missing from home since last Wednesday morning, but Mrs Halstead, his wife, did not feel uneasiness on that account, as he had been in the habit of staying away from home. She had no knowledge that he possessed a revolver and he had never threatened to do anything to himself.

Mr Halstead, who was 51 years of age, belonged to a well known Blackburn family. He was formerly connected with Paradise United Methodist Church. At one time he was a licensed Victualler at Wilpshire hotel.

The discovery was made by John Henry Wilson, a farm servant at Stepping Hey farm. He was engaged spreading manure in a field at Parsonage farm which adjoins Wilpshire moor, on which the body was found. On looking over a stone wall he saw a body lying on the ground behind the wall. Wilson thought the man was asleep, but on going to him saw that he was dead the body being quite stiff.

Four of the five chambers of the of the revolver were loaded and in the other was a spent cartridge. Mrs Sarah Ellen Catlow, of Stonehouse Nook farm, saw the deceased walking in the direction of Wilpshire reservoir at 7am on Thursday. She was apparently the last person to see him alive.

In deceased's pocket was a morning newspaper dated last Thursday and 5s and 3d in money.

On 21 August 1914, Harold enlisted in the army to serve in WW1. His service number was 191. He was 5 feet 8 inches tall and weighed 9lbs 7, I presume this actually means 9 stone 7ozs. His chest was 34 inches and his complexion was fair with brown hair and brown eyes and his religion was given as C of E. He was wounded in the shoulder whilst fighting at the Dardanelles at Gallipoli on 8th May 1915. He returned to Australia in mid 1916 and was discharged due to illness. In 1922 he collected his Victory medal at Manangatang, but he also collected another medal in 1922 from Victoria Barracks in Carlton.

Harold appears to have worked at the Lux Foundry in Brunswick for about 3 years prior to his enlistment, and was re-employed by the foundry after his discharge in 1916. The factory was shut down due to a strike and Harold was forced to find employment elsewhere. He worked at the Naval Store for a short time, and then worked as a labourer for the Brunswick Council for a short time before he moved to Kulwin late in 1920. Harold applied for an Indulgence Passage to return to England in 1916, but this was refused by the State War Council per a letter dated 10 November 1916.

Harold was granted a Soldier settlers block about 1920. The land was described as allotment 23, Winnambool, Kulwin. Kulwin is a locality in Victoria, Australia, located approximately 36 km to the east of Ouyen, Victoria. Kulwin Post Office opened on 16 August 1920 when the railway arrived and closed on 19 November 1974. His postal address was Manangatang. Harold forfeited the land at Kulwin in August 1925.

In April 1937, Harold was living at 9 Argyle Street, St. Kilda but a letter addressed to him dated 2 March 1937 gives his address as 66 Wilson Street, Burnie. He appears to have lived at various addresses in Tasmania, including Burnie and Latrobe from 1932-1936 approx. I have found Harold and Bridget in the 1936 and 1937 Electoral Rolls living at the Central Hotel in Burnie. Harold's occupation is given Manager. It seems Bridget and Harold separated between 1937 and 1943 as they are listed at different addresses in the 1943 Electoral Rolls. Bridget living in Traralgon, Victoria and Harold in Newcastle, New South Wales. I have now discovered that Harold and Bridget divorced in 1942.

Fearful Cruelty to a Child

EXEMPLARY PUNISHMENT

A case was ventilated at the police Court on Tuesday before Messrs M.K. Armstrong and J. Menzies, J'sP., in which an aged woman named Mrs Mary Brennan, a resident of Wedge street, was charged with having cruelly ill-used a child between the 2nd September and the 19th November. The evidence revealed a shocking state of affairs, and had not absolute proof being forthcoming, it would have been extremely difficult to credit that a woman could, so far forget her sex as to practice such fiendish cruelties upon an innocent child. The barbarous treatment that the unfortunate victim received will not likely be forgotten by her for many years to come, and though the bench had power to award imprisonment they did not exercise that right, but inflicted a substantial fine.

The case was brought at the instance of the Victorian Society for the Prevention of Cruelty to, and Neglect of Children, and the prosecution was ably conducted by Sergeant Beck.

The victim of the unmerciful beatings, Elsie Macan, who is a bright, intelligent child gave her evidence in a most convincing fashion and brought-out all the details of her far from pleasurable stay under the inhospitable roof of Mrs Brennan, without any prompting whatever.

The defendant, who was granted permission to sit down, was represented by Mr Palmer, and pleaded not guilty.

Sergeant Beck stated that proceedings were taken under section 117 of the Infant Life Protection Act, the defendant being charged with wilfully ill-treating a girl under the age of 14 years, such ill-treatment resulting in bodily injury to the victim. The bench had power to inflict a penalty not exceeding £50. or award a term of imprisonment not exceeding 12 months. Mrs Brennan was an old resident of the town and was in fairly comfortable circumstances. She resided by herself in Wedge Street. At the latter end of August last she was in Melbourne and agreed with Mrs Macan, a widow residing in East Malvern, to take her daughter, Elsie, aged eight years, who, in consideration of living with her as companion, was to be clothed, fed and sent to school. Mrs Macan and the defendant were strangers prior to the arrangement, which had been brought about by a mutual friend. The defendant took the little girl to Kyneton on the 3rd September, and kept her till the 19th November, on which date she returned her to her mother. Prior to that some enquiries had been made by the police concerning the treatment the child had received. The child was returned to the mother in an entirely different state to when she left her home. She was in a filthy condition, her head being covered with vermin, and a considerable portion of her hair at the back and right side was missing, it having been pulled out. There were marks on the right side of her face, on the ear, the back of the head, and on her right and left arms. He considered that after the bench had heard the whole evidence they would not have the slightest doubt that the case had been fully proved. If they were satisfied he would ask for a severe penalty to be inflicted. The prosecutor concluded with the remark : "It is without doubt one of the most cruel and brutal cases that I have ever seen."

All witnesses were ordered out of court Elsie Macan was the first witness called for the prosecution. Her head was scarcely to be seen in the witness-box, and she was placed on a chair just below the bench. Although she expressed her ignorance of the nature of an oath, she asserted that she knew the difference between truth and untruth, and indicated the consequences that would happen to her in the event of telling a lie. She was allowed to be sworn. Her evidence was as follows:-

My mother resides in Jordan Street, East Malvern. I remember coming to Kyneton with Mrs Brennan. I left her on a Thursday and have been home two Sundays since. During the time I was with Mrs Brennan I went to the Convent School. I had to scrub six rooms at first, and two additional rooms afterwards. I had to chop wood and cut grass with a knife. I was not treated kindly by Mrs Brennan, who beat me across the head with a whip. Nearly every day I received a beating.

Whatever I did I could never please her I was also beaten frequently across the back and face

with a stick, and across the head with a rope. On one occasion I was struck on the back with a box, and on another on the right arm with a soup ladle. When I first went to Kyneton my hair was down to my shoulders, but I had to get it cut since. The defendant often caught me by the hair with her two hands, and dragged it out by the roots. That happened whenever she could not find the whip to beat me. The defendant swung me round by the hair of my head on another occasion, and I caught her by the dress to save myself from falling. I remember the postman coming to Mrs Brennan's place and saying that he would give her in charge if she ill-treated me.

Mrs Brennan told me to say if the police came that I was well treated and got everything I wanted. The marks on my head and arm were caused by the beatings I received from Mrs Brennan with whip, stick, and rope. The bare patches on my head resulted from the hair being pulled out by the defendant.

I was frightened to comb my hair for fear Mrs Brennan would cut it off. I had not sufficient to eat. Sometimes I received dry bread, and other times bread and treacle. I went twice without breakfast and once without tea. I could not find the rope for her one morning and she threatened to pull my hair out. She had also threatened to massacre me, and called me a reprobate, a '97'97 wretch, and an infernal wretch. I was frightened to tell anybody through fear of her. I did not fall down and mark myself. No-one beat me but Mrs Brennan.

To Mr Palmer : It was Mrs Hughes who made arrangements for me to stop with the defendant. I went to the Convent school pretty regularly. I did not tell the nuns of the treatment I received, as Mrs Brennan had threatened to massacre me if I did. It was after Mrs Brennan had shifted to where she now resides that the ill treatment began. Mrs Brennan had told me when I first came to her not to stop talking to people, and not to tell my name. I got milk from Mrs Grant on one occasion and told her my name. Mrs Brennan said she would massacre me with a knife if I so offended again. I never made a complaint to anyone. I wrote to my mother once.

To Sergeant Beck: I had agreed with my mother to put a cross in my letters if I were ill-treated. In the only one I wrote I put that mark. When any person was in the house Mrs Brennan treated me kindly.

Teresa Macan, mother of the last witness, stated she was a widow residing in East Malvern. She had a family of seven to support and was in poor circumstances. Mrs Hughes resided in Windsor, close to where Mrs Brennan's son lived. In consequence of something Mrs Hughes had said, she went to see Mrs Brennan at her son's house. An arrangement was then made that her daughter Elsie should live with the defendant in consideration of receiving a home and every comfort,

She had been led to understand that Mrs Brennan was in good circumstances, and she had let her daughter go believing she would be made happy. It was on the 2nd September that her daughter left home, and she was then in a perfectly clean condition.

There were no marks about her body, head, or face, and her hair was hanging down to her shoulders in curls. When she returned on the 19th ult. she was filthy with vermin; her hair was pulled out in various places, and there were bruises on the arm; left shoulder, back, and side of her head. Her daughter informed her of the nature of her treatment, and she took her to the police station at Malvern. The charge was out, and she then went to Mr Church, secretary of the Society or the Prevention of Cruelty to Children. At his suggestion she visited Dr Stawell's surgery.

Mrs Hughes had not told her that Mrs Brennan had previously ill treated a child. If she had known that the defendant was not a motherly person she would not have entrusted her daughter to her keeping. She had instructed her daughter to put a cross in her letters home if she were not well treated. She had received a letter bearing the Kyneton post mark, and signed "Humanity" informing her of the cruelty practiced upon her child.

Mr Palmer objected to the latter portion of the evidence and the bench held it was not admissible.

Witness (continuing) remarked that the first and only letter she received from her child contained a mark in the shape of a cross. She had complained to the police prior to the child returning home. Her daughter had always been taught to be truthful, and she had never found her out in a lie.

Descendants of John WRIGHT

To Mr Palmer: Her daughter had never a ringworm in her head.

To Sergeant Beck: Mrs Brennan had written then to her saying she was sending her daughter home. Prior to that however, she had made inquiries through the police.

Dr Richard Stawell, practicing his profession in Collins street, Melbourne, deposed that Mrs Macan and daughter visited his surgery on the 20th ult. He examined the little girl and found her bruised on the right cheek.

There were two comparatively recent bruises on the right upper arm and one on the left arm. Her head was partly denuded of hair and was covered with nits and lice The bruises could be caused in the manner stated by the child.

There was no suggestion of any local ringworm to cause the hair to fall at the back of the child's head, neither was there any inflammation about the scalp. The injuries would cause bodily suffering. The child's hands were hard and scratched in places, and it was evident she had used them a good deal in hard manual work. He had ordered the child's hair to be cut off, as it was in a filthy state.

William Noble, an inspector of the Society for the Prevention of Cruelty to Children also gave evidence regarding the condition of the girl, who, in his opinion, must have been a complete slave. Her hands were blistered and scratched, and very hard.

Catherine Slater, who resides two doors from the defendant's place, stated that she had heard Mrs Brennan say to the girl "You _____wretch I will tear all the hair out of your head." Had also heard her abusing her frequently.

Sarah Buscall, age 11 years, said passing the defendant's place one day when she saw Mrs Brennan hitting Elsie Macan with shut fists. The defendant called her a _____wretch at the same time.

Bella Cossons stated that she saw the defendant beating the girl on the back with a stick, and heard her voicing her intention to make her work.

"W. Henry Arblaster, a letter-carrier said he witnessed Mrs Brennan striking the child with her fist on one occasion. He had heard of the defendant's conduct in regard ; to the child, and told her that he would inform the police. She murmured something in reply.

He had a letter for the girl subsequently and saw the defendant near her side gate. Defendant asked him to throw it down. He told her it was not his duty to throw letters about, but she refused to take it. He went to her front door to see if he could see child, and the defendant came out. She asked him again to throw the letter down which he declined. He eventually scaled the side gate and gave the letter to Elsie Macan who was in a little room off the kitchen.

To Mr Palmer: He saw the defendant beating a child some two years ago and spoke to Constable Crimmins about her conduct. He did not send a letter to Mrs Macan pointing out the ill-treatment her daughter received. He was not on familiar terms with Mrs Brennan. Whenever he had a letter for her she snatched it from him.

This closed the case for the prosecution.

Mr Palmer addressed the Bench briefly for the defence. He remarked that the defendant denied that she had ill-treated the child as described. It was a strange thing that the girl had never complained about the alleged ill-usage.

George Cook deposed that on last Thursday week, the girl, Elsie Macan, travelled with him in the train to Spencer street, she did not complain to him about being ill-treated by Mrs Brennan. A young man took charge of her when the train arrived at its destination. Before the train left the Kyneton station he heard the defendant bid bye to the girl, to whom she gave an orange.

Teresa Hughes, a married woman, living in Prahran, stated that she spoke to child asking her if she would like to live with Mrs Brennan. Mrs Macan saw her on the matter and a conversation ensued. Witness told her that the defendant was a bit rough in her ways. She also made it known

that the defendant had a child at one time from St. Joseph's Home, and that somebody having an ill-feeling towards her had complained that the youngster was not well treated. It was ultimately arranged that Elsie Macan should go with defendant. Mrs Macan told her daughter to inform a policeman if she were ill-used, and witness reminded the girl that the nuns would assist her if she were unkindly treated.

Sergeant Beck: Would you not be astonished to know that the girl Mrs Brennan took from St. Joseph's Home had to be removed in consequence of the defendant's conduct ?

Witness replied in the affirmative.

Sergeant Beck : It is a fact then.

Thomas Brennan, a son of the defendant, residing at Windsor, gave unimportant testimony.

John Hunt, licensee of the Kyneton Hotel he had seen Elsie Macan on various occasions during the time she was with Mrs Brennan, and she always appeared to him to be well dressed and well cared for.

This closed the case for the defence.

Defendant did not give evidence on her own behalf.

The Chairman said the evidence for the defence had not really touched the points of the case. It was necessary that the State should protect orphan children boarded out. As a preventive from anyone acting as Mrs Brennan had done, the Bench had decided to fine her £10. Costs amounting to £4 11-11 were also allowed.

The Chairman then addressed the defendant as follows: - It has been given in evidence that you have cruelly ill-treated the child. It is not the first occasion that you have done so. The Bench hopes that the penalty will be sufficient to prevent you misconducting yourself in that way again. <https://trove.nla.gov.au/newspaper/article/240667655>

NEGLECTED
CHILDREN,

- At the police court yesterday morning before Messrs J - E - Andrew and N. Blencowe, J s.P four orphan children, Caroline, Kate, Frances, and John Slater, whose ages ranged from 15 to 4 years, were presented on a charge of being neglected children.

The case was heard in chambers.

Sergeant Beck explained that the father of the children - Thomas Slater - died about 3 years ago, and they were deprived of their mother by death a month since. Since the demise of their mother they had been living with their aunt, Miss Slater, who was unable to support them unaided any longer. Mrs Hurry, the local correspondent of the boarding-out committee, had arranged with Mr Miller, the secretary of the Department for Neglected Children, to have them handed over to Miss Slater in the event of the bench committing them to the care of the department. The eldest girl was 15 years of age. She could neither read nor write and be thought it was far better to have her brought before the court with her sisters and brother and have her made a ward of the State.

Catherine Slater, aunt of the children, stated that she was a dressmaker reading in Wedge street. If granted an allowance she would be willing to look after the children. The eldest girl was strong, but was not very intelligent She had never been sent to school, as her time had been fully employed in attending to her younger sisters and brother.

Mr Andrews: The girl, in my opinion, is not at all weak-minded. In reply to Mr Andrews, Sergeant Beck stated that the department took charge of children up to 18 years of age.

Mr Andrews It would be to the advantage of the eldest girl to have her committed to the care of the department.

Sergeant Beck : Miss Slater has undertaken to have her sent to school regularly.

Mr Andrews: She cannot be compelled to go to school as she is now over the statutory age.

Miss Slater: The nuns have promised to do the best they can for her.

The bench committed the quartette to the care of the department.

Catherine's (Kate) mother died when she was only 9 years old and she was raised by her spinster Aunt, who was also named Catherine Mary Slater. When she was 16 years old she developed rheumatic fever and was sent to her Uncle Alexander Scott in Deniliquin to convalesce.

Catherine was living at Sutherland Street Brunswick when the children were born. Both children have no father registered on their birth certificates, so it is unknown who was the children's father / s, but whether or not Harold was the biological son of John Bonham, he was raised as his son. Catherine never mentioned her first child, but did tell us that she was pregnant one more time, and that she was hit by someone riding a bike and the baby was born prematurely and did not survive. She also mentioned in stories that John Bonham had asked her many times to marry him but for a long time, she refused him. Another story she used to tell was that she was engaged to someone, but she broke it off with him because she found that he had made her best friend pregnant.

2018: With the help of DNA testing, and some good luck, it is now known that Harold's father was in fact a man named Harold Halstead. He was not Reginald's father as Harold Halstead didn't leave England until May 1910 and Reginald was born in June 1910, but several descendants of Harold Halstead's ancestors have strong DNA matches with both Coral Blackwell and Nancye Bonham. On finding that there was no obvious family names shared between these DNA owners, Coral asked one of them if they knew of any male relatives in Australia in 1912. About 18 months later one of the people responded that they had a great Uncle who had come to Australia in the right time period, but that as far as they knew he had not married or had any children. On researching Harold Halstead, it was found that he lived in the same area as Catherine Slater and the same time and with the strong and positive DNA match, it seems almost certain that Harold Halstead is the father of Harold William Slater Bonham.

Catherine lived at Bribie Island, Queensland for many years and returned to Victoria sometime in the 1960's. She lived in a unit at Rosebud for some time and at Garfield with her son Harold and his wife Glad on the farm at 14 Mile Road, she lived at 2 Campbell Street Garfield and also returned to Rosebud at some stage and lived in the same set of units that she had previously lived, but in a unit on the other side of the property. She also lived at 46 Garfield Road, Garfield for a short time in the mid 1970's.

In 1974 she visited to Wonthaggi to spend some time with one of her granddaughters and family. She fell down the steps at the back of the house and didn't call anyone. She took herself back to her bed and the next morning it was discovered she had injured herself badly. She was admitted to hospital with a broken hip and spent many months in the Wonthaggi Hospital, before being transferred to a nursing home in Melbourne where she subsequently died.

She was referred to as Gran or little Nanna by her Grandchildren.

Lena HALSTEAD [10118] (*Maria WRIGHT*⁷, *Thomas*⁶, *John*⁵, *John*⁴, *John*³, *Niccolas*², *John*¹) was born on 15 Apr 1894 in Blackburn, Lancashire, England,⁸⁹ was christened on 27 May 1894 in Blackburn, Lancashire, England,⁹⁰ and died in Mar 1960 in Blackpool, Lancashire, England,⁹¹ at age 65.

General Notes: Lena was an attractive and vivacious outgoing character who took up dancing in the theatre. She was working in the Windmill Theatre in Blackpool when she had a relationship with the Manager, Sid Brandon. Sid was already married with children and much older than Lena. Lena became pregnant to Sid Brandon. Sidney Josolyne, an upcoming magician and illusionist married Lena a month prior to the birth of her child. Sidney Josolyne had already had a child named Lionel with a married woman. Lionel's mother's name was Ouida. Ouida had TB and was in a sanitorium.

Ouida died within an year of Lena and Sid's marriage and Lena took charge of the 2.5 year old Lionel, son of Sidney Josolyne and Ouida, and her own baby Dora Desiree, who was about 6 months old at the time. Sidney was developing a new clairvoyant act and Lena, billed as La Celeste, would perform in the evenings. Lena's skills were applauded and they toured the country performing their popular act.

Sidney had grown up in a strict Victorian household where children were seen and not heard. He expected attention and demanded perfection at home and on stage.

When Sidney's son Lionel was 7, and Lena's child Dora was 6 years old, Lena fell pregnant again. Lionel was quite difficult and about this time he was taken out of school and sent by train to live with foster parents.

Beryl Francis was born during the Edinburgh Festival on March 11, 1926 at 3am. Lena was apparently still performing despite her advanced pregnancy. Beryl was a sensitive little girl who was frequently cared for by her older sister and by her father.

After Beryl was born she remembers playing close to the sands at Blackpool, and being sent to stay with her Auntie Dora, Lena's sister. Lena was not able to show the perfection in her performances that Sidney demanded and gradually began to seek solace in alcohol.

In 1931, Sidney had been working away and returned home to find Lena in bed with another man, Harry Birkby Dunster. Sidney made Lena pack her bags and sent her away with Dora. Beryl was only 5 years old at the time.

Sidney divorced Lena and married another young woman who became the new La Celeste.

Lena married Harry Dunster and they ran a boarding house. Lena stayed in contact with her daughter Dora, but did not see Beryl for many years.

Beryl became a nurse and she had a row with her father and left home and lived with her sister Dora. Harry Dunster had become ill and was a patient in hospital. Beryl went to relieve another nurse and Harry and Beryl had a conversation in which Harry apologised to Beryl for taking her mother away from her. Harry died soon after from cirrhosis of the liver.

Lena went on to marry Ernie Whisker who was a boarder in her boarding house. Dora Desiree convinced Beryl to attend the wedding, this broke the ice and Beryl and Lena were reconciled after many years. Beryl had finished her nursing training by this stage and went to stay with her mother and helped out at the boarding house.

When Beryl married Frank Bartlett, Lena and Ernie Whisker attended the wedding but Sidney Josoyne did not.¹²⁰

Lena married **Sidney Edgar JOSOLYNE** [10119] in 1919 in Fylde, Lancashire, England.⁹² The marriage ended in divorce in 1931. Sidney was born in 1892 in England¹²¹ and died Mar Q 1965 in England,¹²² at age 73.

Sidney then married Agnes Blanche Josolyne [nee Parry who was born in 1909], an attractive young variety artist and clairvoyant, known as La Celeste. A newspaper article states that they were married in 1931 and had a child in 1935, but Mrs Josolyne lived elsewhere for some time.

Sidney Josolyne, husband of (La Celeste) is in the Westbourne nursing home, Links Road, St. Annes on Sea, suffering from a nervous breakdown. He has been seriously ill, but La Celeste says that he is making good progress now and would like to hear from friends

Harold was born prior to the marriage of his mother to John Bonham. On 25 January 2018, with the help of DNA matches with his daughter Nancye and Grand daughter Coral, some good luck and a great deal of research, it has been established that Harold's biological father was in fact a man named Harold Halstead. Further information is being researched at present, but as Coral and Nancye have strong DNA matches with several people down the Wright, Coup and Halstead lines, and Harold Halstead has been placed in the right place at the right time, there would seem no doubt he was Harold Slater Bonham's biological father. I can remember Harold Bonham's occupations as Fisherman at Lakes Entrance and Corinella, poultry farmer at Garfield, shop keeper at Iona, Pallet maker at Longwarry saw mill, Caretaker of the Cardinia Creek Boat Club near Koo-Wee-Rup. I can also remember him milking cows on his farmlet at Garfield and putting the milk cans out on the side of the road for the milk factory to collect. Other occupations included Truck Driver, quarryman, soldier.

Harold lived at Burnley until about 1919, Campbellfield, Broadmeadows East, Inglewood until 1930, Moe until 1936, Trafalgar until October 1936, in Wangaratta working at the filtration plant in 1937, Garfield until March 1940, Jindivick until June 1946, Corinella until June 1953, Poowong for 5 months in 1954, Fish Creek until April 1954, Fish Creek, Iona until January 1956, Lakes Entrance from 1957 until January 1961, Catani February 1961, Scoresby from 1963 to October 1964, the Iona Post Office from 1964 until July 1968, the farm at 14 Mile Road, Garfield from 1969 until October 1972, The Cardinia Creek Boat Club near Koo-Wee-Rup from 1972 until February 1975, the farm at Garfield from 1975 until July 1987, 18 George Street Warragul from 1987 until Aug 1995, 8 Mary Street, North Wonthaggi from 21 August 1995 and finally 78 McBride Avenue Wonthaggi until the time of his death.

Harold was a very private man. He retired when he was 65 and always had a magnificent vegetable garden wherever he lived. At Garfield, then Warragul, and finally at Wonthaggi.

Despite his heart condition, he enlisted in WW2. He enlisted in the Militia Forces in 1932 and gave his address as Post Office Broadmeadows and his occupation as baker. His Army No was 183946. He enlisted in the regular army 28 April 1941 and his number was VX54407. His address at that time was given as Princes Highway, Garfield and his occupation as Quarryman. He was graded as a Group II baker and was sent to New Guinea, and the Middle East, but suffered from serious bouts of malaria and was eventually returned home and discharged. He would rarely talk about his service in WW2 in the 3/3 RAE, with only very scant details being passed on to his family. He never joined the RSL or participated in their activities. In the years before his death, he lived in a small house in Wonthaggi opposite the Cenotaph. On Anzac Day he would walk out to the fence and watch the proceedings, this is the nearest he ever got to participating in Anzac Day.

Wedding photos were taken as everyone was in their wedding gear, but the wedding did not actually take place until the following day. The bridesmaid was Lorna Rodda and the best man was ???? Mick or Mark O'Shea. It is understood that the best man was not able to be present on the actual wedding day due to a previous commitment and Charlie Wallis may have stepped in .

Douglas was the second child and only son of D. Geoff Blackwell and Nancye (Bonham). He lived at Garfield, Victoria, Australia, until he was 14 years old, when his family moved to Wonthaggi, Victoria, Australia. Douglas spent some time unemployed after he finished school, and later worked at Smith and Nephew in Wonthaggi and at Containers Limited, a packaging factory in Dandenong, driving from Wonthaggi to Dandenong daily. He moved to Glenhuntly in approximately 1985 where he had obtained a job working for P.G. Wallace and Co, a Prahran based company, who installed, serviced and maintained communications antennas. He worked all over Victoria installing these towers, but most of the work was carried out in the Melbourne area.

Douglas was an early adopter of computer technology and was adept at computer programming. He was also an amateur (ham) radio operator and enthusiast. He assisted in the early stages of organising and installing equipment for the formation of a local radio Station in the South Gippsland area, now known as 3MFM. He was undertaking a course in electronics at the Swinburne Institute of Technology.

The Rialto Towers (often The Rialto) is the second-tallest reinforced concrete building and the tallest office building in the southern hemisphere, when measured to its roof (several other skyscrapers in Australia are taller if their spires are included, as are some other structured in Australia such as communications masts and observation towers). The building is located at 525 Collins Street, in the western side of the central business district of Melbourne, Australia.

The Rialto Towers featured Melbourne's first skyscraper public observation deck which

operated between 1994 and 31 December 2009 It was also the location of Melbourne's first Tower running event.

At the time of its completion it was the 23rd tallest building in the world and the 2nd tallest outside of the United States (behind First Canadian Place in Toronto, Canada). Construction of the Rialto Towers was completed in 1986.*(Wikipedia Feb 2012)

P G Wallace and Company installed the communications towers on the top of the Rialto building. Douglas, who was initially very unhappy working at height, soon got used to it, and would proudly recount the fact that he and his workmates used to fly paper aeroplanes from the roof of the Rialto building during its construction and the installation of the communications towers.

Douglas left this job with P.G. Wallace and Co in mid 1988 and commenced working for a company called Australnet Communications that installed car telephones that operated from Mount Waverley. This was an infant industry at the time.

In his younger years Douglas played the cornet in the Wonthaggi Citizens Band, and played competition table tennis at Wonthaggi. He also enjoyed archery. As a child and into adulthood he built and flew model planes, eventually branching out into radio controlled equipment including planes, cars and boats. He competitively raced radio controlled sailing boats on the Albert Park Lake in Melbourne.

As children, Douglas and his sisters learned to ride motorbikes, which were ridden at Garfield on Theadora Fenn's land which was about 6 acres. Eventually Douglas obtained his motorbike licence and rode his bike to work in Melbourne trying to save fuel costs. He had purchased a 125cc racing motorbike which he was preparing to race in 1989.

Douglas was on his way to work at his new job at Australnet Communications, where he had been working for only 2 weeks, when his motorcycle hit a speed hump in the road, only about 2 kms from his home in Glenhuntly. He lost control of the machine and was critically injured and taken to the Alfred Hospital in Melbourne, where he remained in a critical condition for one month, but finally succumbed to his injuries on the 5th of December 1988.
